

**Notes to the Financial Statements**  
**December 31, 2010**

**1. Accounting Policies**

Donations are recorded as revenue when received. Expenses are recorded on an accrual basis as incurred.

**2. Grant Payable**

In 2009, WMFC committed to fund a research grant at the BC Cancer Agency in the amount of \$99,935 payable in instalments, the first of which was paid in December, 2009 in the amount of \$24,985, the second of which was paid in June 2010 of \$24,985. WMFC is committed to pay the balance of the grant as follows, subject to receipt of satisfactory progress reports:

**3. Incorporation**

The WMFC was incorporated as a corporation without share capital under the Laws of Ontario on October 5, 2001. It received notification of registration as a charity under the provisions of the Income Tax Act effective December 27, 2002. It commenced operations in 2003.

**4. Status**

The WMFC has been designated as a charitable organization for the purposes of the Income Tax Act (149(I)(f)).

**5. Objects**

The objects of the WMFC are:

- a. to undertake public education, family support services, dissemination and publication of information about Waldenstrom's macroglobulinemia disease, and to coordinate medical care and social services for persons suffering from Waldenstrom's macroglobulinemia;
- b. to provide funds for research into the cause, control and cure of Waldenstrom's macroglobulinemia.
